<p><b>Action for VCS</b>  <b>2 - Parenting programmes for the City</b>  <b>It was agreed for focus to be on 4 main ones including;</b>  <b>Supporting Families, Supporting Communities (?)</b>  <b>Triple P</b>  <b>Mellow Parenting</b>  <b>Family Links</b>  <b>It was noted that while there are many trained practitioners not many were actually delivering</b>  <b>A need to remind all practitioners and their managers of their initial commitment to deliver training to parents once trained.</b></p>

**Importance to ensure that which ever course is delivered that the messages to parents is consistent**  
**Need was identified to ensure the continuing CPD of all trained practitioners -this is being considered**
